This document outlines the policies and terms and conditions governing the relationship between F4N Shot Live Streaming App and its Business Developers. By becoming a Developer, you agree to adhere to these guidelines.

1. Business Developer Responsibilities:

Agent Recruitment: Developers are responsible for actively recruiting and onboarding new Host Agents ("Agents") to the App.

Agent Management: Developers are expected to provide ongoing support and guidance to their recruited Agents, including but not limited to:

- · Assisting with onboarding processes and App navigation.
- Providing strategic advice on Agent recruitment and Host management.
- Ensuring Agents adhere to the App's policies and terms.
- Troubleshooting issues and escalating problems as needed.

Performance Monitoring: Developers are responsible for monitoring the performance of their recruited Agents and encouraging consistent activity and growth.

Communication: Developers must maintain regular and professional communication with both the App administration and their recruited Agents.

Policy Adherence: Developers must strictly adhere to all App policies and terms of service.

Minimum Active Agents: Developers must maintain a minimum of 2 active Agents at all times. "Active" is defined as an Agent that meets the minimum active host requirement, as defined in the Agent policy.

Strategic Growth: Developers are expected to develop and implement strategies to expand the App's user base and revenue.

2. Business Developer Compensation:

Commission: Developers will receive a commission on their level of the total earnings generated by their recruited Agents.

Payment Schedule: Commissions will be paid according to the App's established payment schedule, which will be communicated to Developers upon onboarding.

Earnings Calculation: Earnings used for commission calculation will be based on the Agent's verified earnings after any applicable deductions.

Payment Method: Payments will be made via the designated payment method provided by the Developer.

Eligibility: Commissions will only be paid for earnings generated by Agents who are actively following the app's terms and conditions, and who are in good standing.

3. Agent Requirements:

Compliance: Agents must comply with all App community guidelines and terms of service.

Performance: Agents must meet the performance requirements outlined in the Agent Policy.

Minimum Host Numbers: Agents must meet the minimum host numbers as outlined in the agent policy.

4. App Rights and Responsibilities:

Policy Changes: The App reserves the right to modify these policies and terms at any time. Developers will be notified of any changes.

Account Termination: The App reserves the right to terminate a Developer's account for violations of these policies or for any other reason deemed necessary.

Payment Adjustments: The App reserves the right to adjust commission payments in cases of fraud, errors, or policy violations.

Support: The App will provide reasonable support to Developers in fulfilling their responsibilities.

Data Usage: The app will handle all personal data in accordance with the apps privacy policy.

Final decision maker: The App holds the right to final decision in all disputes.

5. Business Developer Terms and Conditions:

Independent Contractor: Developers are independent contractors and not employees of the App.

Confidentiality: Developers must maintain the confidentiality of all App information, Agent data, and Host data.

Non-Compete: Developers agree not to recruit Agents for competing live streaming platforms.

Liability: Developers are responsible for their own actions and will not hold the App liable for any damages or losses.

Agreement Acceptance: By becoming a Developer, you acknowledge that you have read, understood, and agree to these policies and terms.

Minimum Agent Requirement: If the developer fails to maintain 2 active agents, the App reserves the right to terminate the developer's contract.

Intellectual Property: All intellectual property related to the App remains the property of the App.

6. Dispute Resolution:

- Any disputes arising from this agreement will be resolved through amicable negotiation.
- If negotiation fails, disputes will be subject to the jurisdiction of the laws of the location where the App is registered.

7. Amendments:

- The App reserves the right to amend these policies and terms at any time.
- Developers will be notified of any changes through the App or via email.
- By proceeding as a Business Developer, you acknowledge and agree to these terms and conditions.
