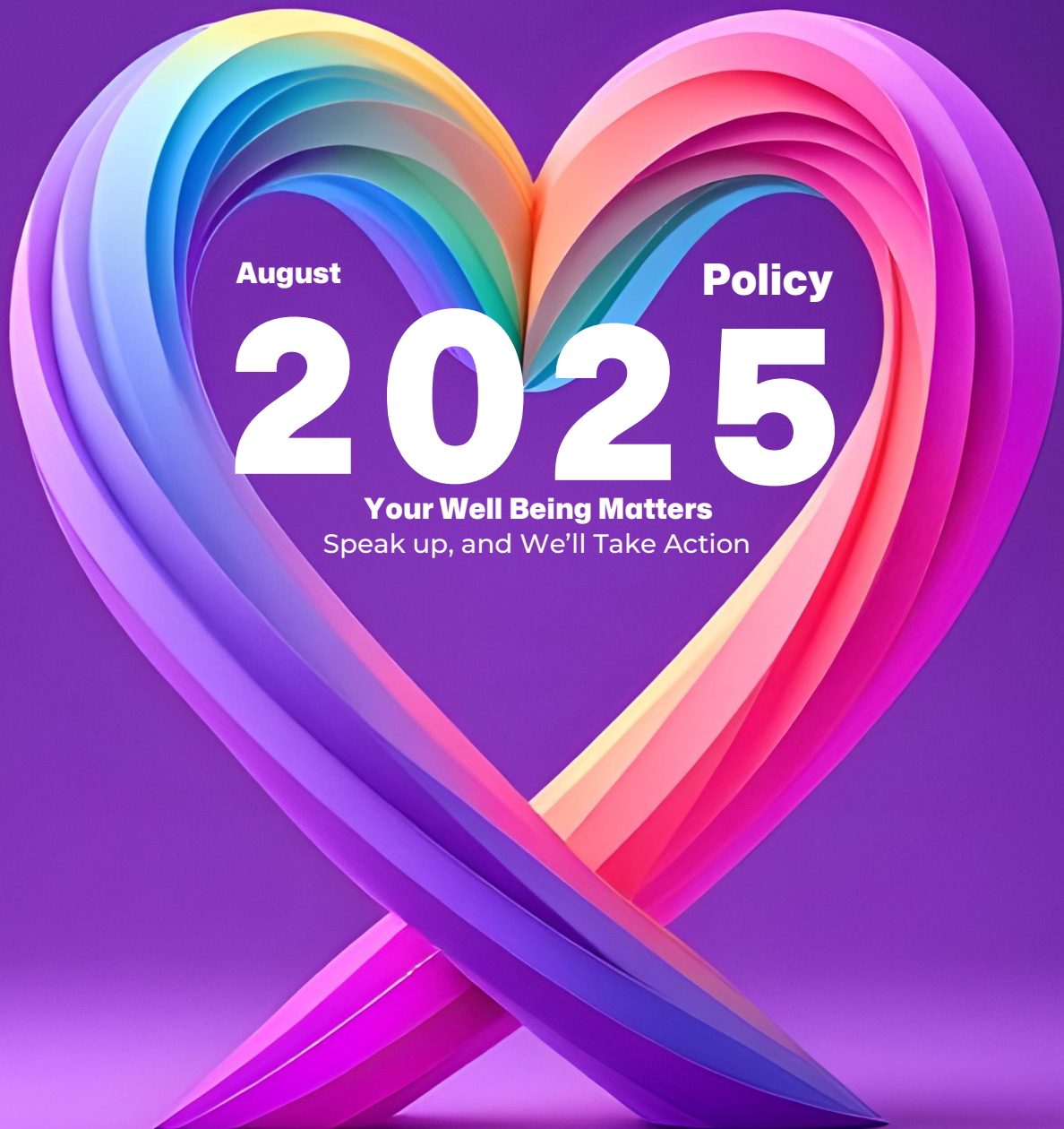

## FunShot Overview

- **Monthly Targets:**

Targets are defined on a calendar month basis from the 1st to the last day of every month.

- **Currency Conversion:**

1 USD = 95 INR

\$ to Diamond Conversion : 1 USD equals 4000 Diamonds

- **Gifts Receiving Ratio:**

A full 100% ratio applies to gifts received.

- **Salary Details:**

100% of your Salary will be paid from the 1<sup>st</sup> to the 5<sup>th</sup> of the month directly to the host

- **Commission and Rewards:**

- 15% Agency Commission
- 5% Room Reward
- 5% Family Commission & Other Rewards  
(only eligible when the family participates in Task)

## ***Terms & Conditions :***

- Blank Screen/ Black Screen (More than 90 Seconds or host constantly absent from camera for over 3 times).
- Looking away from the camera for a long time.
- The sound has non-background music: such as TV, etc.
- Looking down, not interacting or looking elsewhere for a long time.
- The live broadcast scene is wrong: outdoor or long-term continuous microphone chat, low quality.

- **Important Notice:**

- Host age should be 18+, if not salary will not be released and host id will be banned
- The approved result will be disclosed in 24 hours by the official admin

- **Terms of Compliance:**

Hosts must ensure that the following behaviors will not occur during the live broadcast:

### **A. Prohibited Types of Speech:**

- Hate speech, which promotes or encourages discrimination, harassment, or violence based.
- On race, ethnicity, gender identity, sexual orientation, age, religion, or nationality.
- Harassment, defamation or intimidation..
- Misleading or false statements about F4NShot, its product, features or policies.
- Advertising for illegal or inappropriate merchandise.



#### **D. Prohibitions in regard to Broadcasting Venues & Circumstances:**

- Streaming in adult entertainment venues, such as a night club or an exotic dance club.
- Filming another individual without their consent or against their will.
- Unauthorized broadcast or transmission of copyrighted content.

#### **F. Criminal Activity:**

- Facilitating or organizing criminal activities.
- Causing direct or indirect physical or financial harm to people, animals, property, or businesses.
- Inciting ethnic hatred or ethnic discrimination.
- Celebrating any crimes committed, either by the user or by a third party.

#### **E. Nudity or overly sexualized content:**

- Exposure of any genitalia at any time.
- Inappropriate or revealing clothing\* (Read Dress Code).
- Sexually suggestive or provocative activity, which includes any sexual gestures, posture, dances, and/or general sexual behavior.
- Sexually charged language, both on camera and/or in the comments section or in the broadcasts title.
- Offers of sexual services including prostitution, escort services, sexual massages, and/or filmed sexual activity.

#### **B. Violent, Self-Harming or Self-Mutilating Acts or Threats:**

- Display of firearms, promotion of gun violence.
- Death threats or threats of violence or harm against any individual or community.
- Depiction of or advocacy for child abuse, animal cruelty, self-mutilation, bodily harm.

#### **C. Bullying, Harassment, Or Hateful Language:**

- Profanity and/or vulgarity that is meant to hurt or attack.
- Hate speech - Discriminatory or humiliating remarks based on: race or ethnic origin, religion or belief, disability, gender, age, nationality, appearance or physical attributes, or sexual orientation/gender identity.



## **H. Victim:**

- Sharing/displaying personal info of an individual for the purpose of blackmail or harassment.

## **G. Sales and Promotion of Illegal Substances:**

- Use, mention or display of illicit drugs and/or drug paraphernalia.

## **Termination and Suspension:**

- We have the right to suspend and stop payments to hosts that violate T&Cs.
- We have the right to terminate any relationship with the host at any point of time in case of the host violating T&Cs.
- Abuse in the room is **NOT ALLOWED**.
- Hosts who have 2 Host IDs will not be paid any salary and their ID's will also be banned.

# ***F4NShot ID Unban Request Process :***

## **1. Identifying the Correct Channel:**

### **• Support Rooms :**

Users should locate the F4NShot Support Rooms. Here, they can post or initiate a conversation with a moderator or support representative.

### **• Email Contact :**

Alternatively, users can directly email F4NShot Support. Look for the official support email address provided in F4NShot's help or contact sections.

## **2. Preparing Your Request:**

### **• Gather Information :**

- **Account Details :** Include your username/ID and registered email address or phone number to help verify your identity.
- **Context of Ban :** Summarize what led to your ban, including dates or events if possible.

- **Crafting the Message :**

- **Explain your Situation:** Provide a clear, concise explanation of why you believe the ban should be lifted. Include any misunderstandings or extenuating circumstances that might have contributed to the issue.
- **Supporting Evidence:** If available, attach any evidence (screenshots, videos, etc.) that support your case.
- **Acknowledge Policies:** Indicate that you have reviewed F4NShot's guidelines and understand the rules. Express your commitment to comply with these in the future.

### **3. Submitting The Request:**

- **Via Support Rooms :**

- Join the designated support room and either post your unban request or initiate a private message with a moderator.
- Ensure that your message follows any room-specific guidelines or formatting rules.

- **Via Email :**

- Compose an email with a clear subject line (e.g., "Request for ID Unban – [Your Username]").
- Include all the information and attachments as detailed above.
- Send the email to the official support address.

### **4. Acknowledgment and Initial Response:**

- **Confirmation :**

- After submitting your request, you should receive an acknowledgment—either through the support room or via email. This will usually include a reference number or a timeline for when you can expect a response.

### **5. Review Process by F4NShot Support:**

- **Assessment:** The support team will review your submission. They will verify your account details, assess the context of the ban, and compare your case against community guidelines.

- **Follow-Up:** If additional information is needed, a support representative will contact you via your provided email or within the support room.

## 6. Decision and Communication:

- **Final Decision:**

- **Approval :** If your case is approved, you will be notified that your ID has been unbanned along with any conditions or recommendations for future conduct.

- **Denial :** If your request is denied, you will receive an explanation. The communication may also outline any further steps or appeal options available to you.

### Terms & Conditions :

- Agency Commission Depends on Host Count as well
- No Carry forward for points for next month

### Host Terms & Conditions :

- Non-Payment of Host Salary: If an agency owner fails to pay a host's salary for the previous month, a formal notice and warning will be issued to the agency.
- Host Inactivity: If a host remains inactive for 90 days, their hosting privileges will be automatically revoked.
- New ID Creation: If a host creates a new ID without informing the agency or the F4n Shot team, the new ID will be transferred to their original agency.

### Extra Rewards :

- Agency can get 100 Dollars after making 35 new female host active in one month
- Agency can get 20 Dollars after making 10 new female host active in one month



This document outlines the policies and terms and conditions governing the relationship between F4N Shot Live Streaming App and its Host Agents. By becoming an Agent, you agree to adhere to these guidelines.

## 1. Agent Responsibilities:

**Host Recruitment:** Agents are responsible for actively recruiting and onboarding new live stream hosts ("Hosts") to the App.

**Host Management:** Agents are expected to provide ongoing support and guidance to their recruited Hosts, including but not limited to:

- Assisting with account setup and App navigation.
- Providing advice on content creation and audience engagement.
- Ensuring Hosts adhere to the App's community guidelines.
- Troubleshooting technical issues.
- Performance Monitoring: Agents are responsible for monitoring the performance of their recruited Hosts and encouraging consistent activity.

**Communication:** Agents must maintain regular and professional communication with both the App administration and their recruited Hosts.

**Adherence to Policies:** Agents must strictly adhere to all App policies and terms of service.

**Minimum Active Hosts:** Agents must maintain a minimum of 5 active Hosts at all times. "Active" is defined as a host that does a minimum target of 1 Lakh.

## 2. Agent Compensation:

**Commission:** Agents will receive a commission of 15% of the total performance by their recruited Hosts.

**Payment Schedule:** Commissions will be paid according to the App's established payment schedule, which will be communicated to Agents upon onboarding.



**Earnings Calculation:** Earnings used for commission calculation will be based on the Host's verified earnings after any applicable deductions.

**Payment Method:** Payments will be made via the designated payment method provided by the Agent.

**Eligibility:** Commissions will only be paid for performance by Hosts who are actively following the app's terms and conditions.

### **3. Host Requirements:**

**Compliance:** Hosts must comply with all App community guidelines and terms of service.

**Content Standards:** Hosts are responsible for creating and broadcasting appropriate and engaging content.

**Activity:** Hosts must maintain a minimum level of activity, as defined by the App, to be considered active.

**Account Verification:** Hosts must complete the account verification process as required by the App.

**Minimum age:** Hosts must be 18 years of age or older.

### **4. App Rights and Responsibilities:**

**Policy Changes:** The App reserves the right to modify these policies and terms at any time. Agents will be notified of any changes.

Any disputes arising from this agreement will be resolved through amicable negotiation.

If negotiation fails, disputes will be subject to the jurisdiction of the laws of the location where the App is registered.

## **F4N Shot Creator Policy :** Content and Monetization Guidelines

### **Green Tick :**

- 500 Views per video for 6 Video's
- Top 3 Green Tick will be converted to Grey Tick
- Minimum 10 Videos required for maintaining Green Tick

### **Grey Tick :**

- 12000 Views on Total videos throughout app journey
- 2000 Views each videos for 6 Videos
- Minimum 3 months - Consistency
- Minimum 15 Videos required for maintaining Grey Tick
- Top 3 Grey Tick will be converted to Blue Tick

### **Blue Tick :**

- 100 Videos should be uploaded throughout his app journey

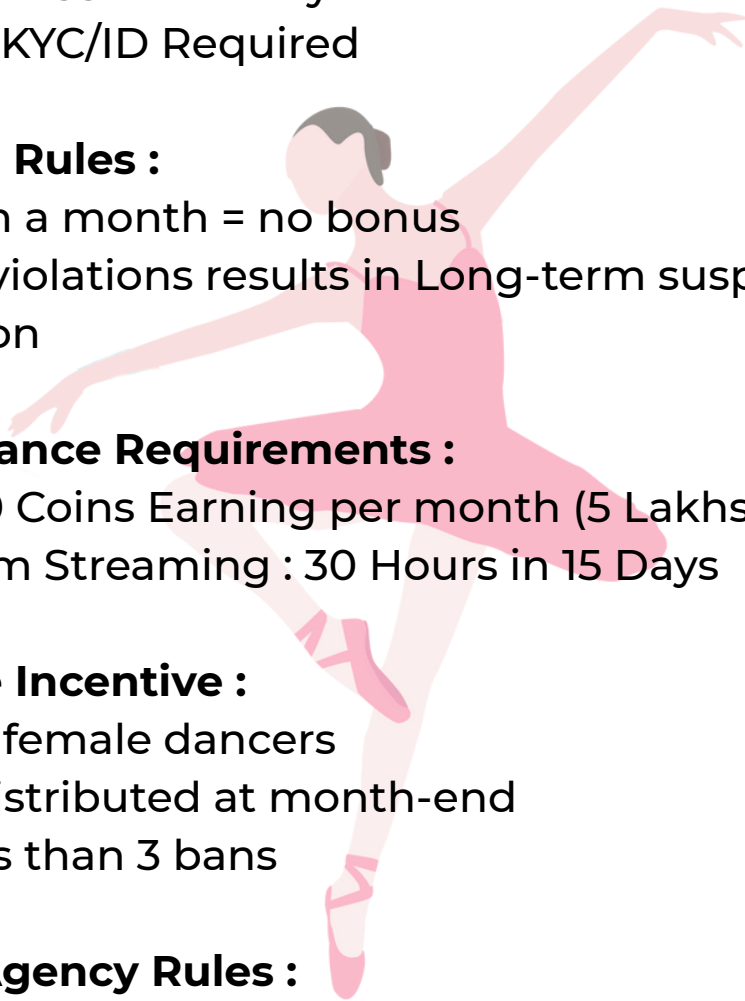
